The Chamber's Government Affairs Committee works on behalf of the Chamber members to identify and analyze public policy issues and provide recommendations on such matters to the Chamber's Board of Directors. In addition, the Government Affairs Committee works to actively represent the Chamber's positions in legislative, municipal and regulatory forums that deal with issues important to the Chamber's members. In the next two months we will be focusing on state legislative issues that affect Boca Raton area businesses.

Government Affairs Committee members participated in a "fly-in" to Tallahassee March $6^{th}-8^{th}$. The purpose of our trip to Tallahassee was to meet with all of our area's elected state representatives and senators to promote a healthy business environment in Palm Beach County and Florida. March is the heart of Florida's legislative session. Making a visit during the legislative session sends a strong message of our interest and desire for action on matters important to our members. We made presentations to our local representatives to recommend action on the following key state initiatives endorsed by the Greater Boca Raton Chamber of Commerce Board of Directors:

- Support HB537/ SB528. Prohibits an initiative or referendum process relating to a local comprehensive plan amendment or map amendment change.
- Support HB 655/SB726. Blocks local Governments from adopting paid sick time measures.
- Support HB 605/SB662. Lower's Worker's Compensation insurance costs by stabilizing the cost of prescription drugs dispensed by physicians.
- Support HB629/SB656. Reduction of Sales Tax on rental commercial real estate property.
- Support reinstating the 2012-2013 reduction of \$300 million in the 2013-2014 higher education budget.

We look forward to interacting with our elected officials. The Government Affairs Committee will monitor the results of our efforts and keep you informed of the outcomes in future editions of this newsletter. Thank you for your support.

City & County News

- In reaction to a string of arrests in Florida and other states regarding the improper use of proceeds derived from internet cafes, the House Select Committee on Gaming heard HB 155 by Representative Trujillo. The language contained in the bill calls for an outright ban on Internet Cafés and other similar businesses. Palm Beach County has had a moratorium on the cafes in our area but that is scheduled to expire in March.
- The State Revenue Estimating Conference increased projected tax revenues at a meeting Friday. The economists added \$153 million in tax revenues in the budget year that ends June 30, and \$106.5 million for the year that begins July 1st.

State News

- Business Identity Theft is growing exponentially in the State of Florida. Florida is the only state to have a department dedicated to helping victims of this crime and organizing the methods needed to prevent it. In 2011, it was a 50 billion dollar crime nationwide. - Florida has the 41st worst legal climate ranking and puts our state in the bottom 10 in the nation a reputation that does nothing to attract new businesses or give existing business owners the confidence they need to grow their business, make investments or increase their workforce. - Did you know that while Florida is the fourth most populous state, we rank 15th in manufacturing activity? Manufacturing Fast Facts
 - Manufacturing represents 3% of Florida's economy relative to employment and 5% of Gross State Product.
 - $^{\circ}$ Over the last decade, Florida lost 118,838 workers while gaining \$6.9 billion in Gross State Product.
 - The industry's average wage for Florida is \$51,848, which is higher than the overall Florida average of \$41,574.
 - 340,093 Floridians are employed in the Manufacturing Industry- approximately 3% of Florida's total employment.
