- Submit your event press release (150-180 words) to amiuccio@bocachamber.com before June 15th. **PRESS RELEASE MUST INCLUDE:
 - The phrase: **[your event name]** is part of Boca Chamber Festival Days - a series of fun-filled events held at different locations during the month of August - and is facilitated by the Boca Chamber.*
 - Who, What, When, Where, Why, Cost, Sponsor, Registration Information (if available)*
- 300 printed flyers of your event delivered to the Chamber by July 2nd.
- Report proceeds raised from your Boca Chamber Festival Days event to Alison Miuccio by September 7th.

Your entry fee of \$300 (per event) includes:
