Sponsorship Opportunities:

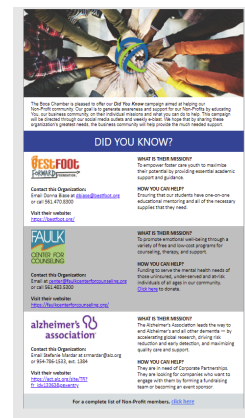
